

Wisconsin University Union (WUU) Beck-Elder Awards

The Wisconsin University Union announces a call for the Beck-Elder Awards in support of WUU's mission.

Background

WUU is an independent association of faculty and academic staff at the University of Wisconsin-Madison. We promote the values of our members in the activity and organization of this campus. Our core values reflect a commitment to democracy – an order of free and equal persons who determine the conditions of their own association. WUU has a long history of supporting University faculty and staff members who find themselves in conflict with their employer.

About the Awards

- **Support Types:** research/outreach projects; assistance with member's legal fees
- **Budget:** up to \$5000. Note that awards are made directly to individuals or organizations.
- **Process:** submit a 1-2 page proposal as described below, followed by a short interview for the finalists.
- **Timeline for assistance with member's legal fees:** ongoing
- **Timeline for research/outreach projects:**
 - Submission by: February 1, 2023
 - First round evaluation by: March 1
 - Presentations: Week of March 15
 - Final determination: March 31

Subsequent rounds of proposals will follow.

Funding Priorities (in no particular order of importance)

- **Support of shared governance at UW-Madison**
- **Ensure equality under due process at UW-Madison**
- **Promote labor and employment rights of faculty and staff at UW-Madison**
- **Promote diversity, equity and inclusion in employment at the UW-Madison**

- **Legal counsel for individuals or groups of individuals at UW-Madison**

All proposals must be submitted and sponsored by a member of WUU.

Membership is open to all faculty and academic staff, emeritus members of the faculty and retired members of the academic staff of the University of Wisconsin-Madison and the UW-Extension. Research/outreach proposals must produce an evidence-based output : Qualitative or quantitative report, recommendations, history, publication, film, recording, event, public art or performance that exhibits lived experience.

For assistance with legal fees, please include what steps have already been taken to address your concerns, why legal counsel is needed at this time, and why WUU's support is needed; **WUU members are encouraged to reach out at any time about the need for counsel or employment issues, with or without a formal application.**

Proposals will be screened and finalists will be required to make a short presentation and discuss the project as the last step in determination of awards.

Examples of desired research/outreach topics on shared governance, evaluation, promotion, pay, harassment, contracts, interactions, diversity, inclusion, or equity:

- Representative survey, report or analysis of UW-Madison faculty and staff experience or attitudes.
- Events, performance, art or illustrations of UW-Madison faculty and staff experience or attitudes.
- Qualitative research or histories (oral, written or video) of UW-Madison faculty and staff experience and attitudes.
- Case studies, curricula or educational campaigns related to UW-Madison faculty or staff experience or attitudes.
- Assessment of the impact of ACT 10 on ability of faculty and staff to organize and participate in shared governance; or on salary, benefits, employment evaluation, job security, promotion, hiring, contracts, harassment, equity, diversity, or inclusion.
- Effects of abortion laws on recruitment of faculty/postdocs/grad students.
- Number and reasons for faculty and staff attrition, early retirement.
